



EnergyWall Windows & Doors® coating is guaranteed under normal conditions for a period of twenty (20) years, against weathering, specifically, but not limited to, "peeling or blistering from/on the applied surface and significant ultraviolet discoloration" (greater than 6 Delta E units) caused by natural environmental atmospheric conditions. Should the painted window fail, due to product defect, EnergyWall Windows & Doors will replace the painted window free of charge for twenty years. Labor to remove or re-install a window is not covered by this warranty. Windows must be inspected at the time of delivery. Any defect/ damage must be reported to customer service at that time. The warranty is not applicable under the following conditions:

• If damage is caused by an external factor ex: Stucco leach, acidic washes, hard tack tapes, blowing sand, or installation damage.

- If damage occurred during installation or transport of the painted PVC windows to the job site.
- Any act of God.

If the unit fails to perform in accordance with the above statements during the applicable warranty period, EnergyWall Windows & Doors shall, upon notification and validation of the complaint by inspection by its designated representative, supply a replacement for the non-conforming unit or grant a credit for a portion of the cost of the unit, as herein after specified. EnergyWall Windows & Doors obligation under this Limited Warranty is to supply a replacement unit for the non-conforming unit FOB EnergyWall Windows & Doors nearest active dealer to the installation during the Limited Warranty period.

Labor of any kind or other cost to remove the non-conforming unit and/or to install the replacement unit is not included in this Limited Warranty. EnergyWall Windows & Doors shall bear no other expense of any kind and the Original Purchaser's exclusive remedy shall be replacement or credit on the basis stated. The Original Purchaser shall pay any and all labor cost necessary to install replacement units.
